- d. Last Three financial year balance sheet and Profit /Loss account should be produced.
- e. Company should have executed 2 orders of about 5 lakhs or above.

#### 8. Payment:

Payments shall be made promptly by the KEONICS but in no case later than sixty (60) days after submission of the invoice with satisfactory maintenance report from the concerned. While submitting the monthly bill, the selected Bidder has to submit the engaged personnel ESI, EPF and Service Tax paid Challans. All the relevant documents as

per work order which are required maintenance of STP are to be submitted along with the bill.

Every month after successful complete execution of the work as per scope of work mentioned, Inspection and with work Satisfaction Certification authorized by Asst. Manager/Senior Assistant IT park Kalburagi & IT park Shivamogga.

#### 9. Inspections and Tests

KEONICS shall have the right to inspect and/or to test the Chemicals and related materials of STP to confirm their conformity to the Contract specifications at no extra cost. The selected Bidder /Vendor shall deploy the experienced person/ persons for maintenance, test and inspection of STP Plant at KEONICS IT Park Kalburagi & KEONICS IT Park Shivamogga their details are to be submitted to KEONICS.

The details of the chemicals and specifications used for maintenance of STP are recorded in log book and the same details are submitted along with the bill. The same chemicals are to be inspected and tested at STP Plant at KEONICS IT Park Kalburagi. If any inspected or tested Goods fail to conform to the specifications, KEONICS may reject the goods and the Selected Bidder shall either replace the rejected Goods or make alterations necessary to meet specification requirements free of cost to KEONICS. For any untoward incident/ disaster at STP Plant

#### 10. Force Majeure

Notwithstanding the provisions of GCC Clauses 21, 22, 23, the Selected Bidder shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

For purposes of this Clause, "Force Majeure" means an event beyond the control of the Selected Bidder and not involving the Selected Bidder's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the KEONICS either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

If a Force Majeure situation arises, the Selected Bidder shall promptly notify the KEONICS in writing of such conditions and the cause thereof. Unless otherwise directed by the KEONICS in writing, the Selected Bidder shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

#### **11.** Termination for Insolvency

The KEONICS may at any time terminate the Contract by giving written notice to the Selected Bidder, if the Selected Bidder becomes bankrupt or otherwise insolvent. In this event, termination will be without compensation to the Selected Bidder, provided that such termination will not prejudice or affect any right of action or remedy which has accrued or will accrue thereafter to the KEONICS.

#### **12.** Termination for Convenience

The KEONICS, by written notice sent to the Selected Bidder, may terminate the Contract, in whole or in part, at any time for its convenience. The notice of termination shall specify that termination is for the KEONICS's convenience, the extent to which performance of the Selected Bidder under the Contract is terminated, and the date upon which such termination becomes effective.

The Goods that are complete and ready for shipment immediately after the Selected Bidder's receipt of notice of termination shall be accepted by the KEONICS at the Contract terms and prices. For the remaining Goods, the KEONICS may elect:

(a) To have any portion completed and delivered at the Contract terms and prices; and/or

(b) To cancel the remainder and pay to the Selected Bidder an agreed amount for partially completed Goods and for materials and parts previously procured by the Selected Bidder.

#### 13. Nature of Duties:

Without prejudice of the responsibilities of the agency mentioned in the insuring clauses, the agency shall in particular required to render operating and maintenance services to the STP and makes all arrangements incidental there in STP campus.

#### 14. Duty points and Locations.

This Maintenance Services shall be performed by the Agency through their men on the basis of day to day and shift requirement as per the instructions of the officer-in-charge, SEWAGE treatment plant.

#### 15. Deployment

The name of the personnel deployed on the premises with their Bio-Data, Photograph, and Aadhar Card shall be furnished. Every month attendance should be certified by concerned officers of respective KEONICS IT Park. Attendance register of personnel deployed are to be maintained at respective STP plant. Certified copy of the attendance should be submitted regularly during the payment.

Adequate provision/ arrangement should be made against leave reserve, weekly off etc., by the selected bidder well in advance.
